**Resolution No. 2024-247**

**DECLARING THE BID OF JONALYN P. LAURIAN, PROPRIETOR OF HEXACOM ENTERPRISES AS THE LOWEST CALCULATED RESPONSIVE BID (LCRB) FOR ITEM NO. A-E & G UNDER PROJECT PROCUREMENT OF VARIOUS INFORMATION TECHNOLOGY (IT) EQUIPMENT FOR BENGUET STATE UNIVERSITY (IB NO. 2024-16) AND RECOMMENDING THE AWARD THEREOF TO THE SAME BIDDER**

WHEREAS, the BENGUET STATE UNIVERSITY (BSU) published the Invitation to Bid for the project **PROCUREMENT OF VARIOUS INFORMATION TECHNOLOGY (IT) EQUIPMENT FOR BENGUET STATE UNIVERSITY (IB NO. 2024-16)** at the PhilGEPS and BSU website and posted the same in four (4) conspicuous places, in the Bulletin Board of Barangay Betag, La Trinidad Municipal Building, Barangay Balili and the University continuously from February 28, 2024 until March 19, 2024;

WHEREAS, in response to the invitation Six (6) bidders namely: **Techstream Enterprises** (Jonathan D. Calantas), **Catalyst Computer Office Equipment Wholesaling** (Allen A. Tolding), **Ants Technologies** (Abigail D. Imperial), **Hexacom Enterprises** (Jonalyn P. Laurian), **Infoworx Inc.** (Frederick Lao) and **Tionsan Corporation** (Manuel D. Supat, Jr.) bought bid documents and dropped their bids before the scheduled submission at 2:00 p.m. of March 19, 2024;

WHEREAS, upon checking the legal, technical and financial documents submitted by the bidders, using the “pass/fail” criteria, the bid of **Techstream Enterprises** (Jonathan D. Calantas) particularly for the item F was declared ineligible due to non-compliance to the item 10 of both section 2, Instructions to Bidders (IB) and Section 3, Bid Data Sheet (BDS) of the Philippines bid documents, thus its financial offer was kept sealed, while the bid of the others bidders were declared eligible. Thus, their financial offers were opened.

WHEREAS, the bid of **Ants Technologies** (Abigail D. Imperial) for item **F**; **Hexacom Enterprises** (Malou Y. Yusongco) for item **A, E and G**; **Infoworx Inc.** (Frederick Lao) for item **B**; and **Tionsan Corporation** (Manuel D. Supat, Jr.) for item **C and D**, was determined by the BAC as the Lowest Calculated Bid (LCB) under the project (**IB NO. 2024-16**) and recommended for post qualification with the assistance of the TWG and end-user (see table 1). To facilitate the post qualification process, the TWG was directed to evaluate the bid of the other bidders.

**WHEREAS**, the reports of the TWG provide the following: **Hexacom Enterprises** submitted SLCC with conflicting details with that of the certificate of acceptance by DOLE for the same projects; **Infoworx Inc.**, was non-compliant to the technical specification particularly item 1 of lot B (Laptop Computer) and the list of on-going contract submitted has discrepancies; **TSS Corporation** was non-compliant with the technical specification particularly item 2,3& 4 of lot A ( Desktop Computer), item 1 of lot B ( Laptop Computers) and violation of Section 25 of the IRR of the RA 9184; **Ants Technologies** submitted contracts with delivery period having lapsed as on going contracts without any proof of approved extension of the periods.

**WHEREAS**, upon verifications and validations, the BAC declared the bids of **Infoworx Inc.** (Frederick Lao), **Tionsan Corporation** (Manuel D. Supat, Jr.), **Ants Technologies** (Abigail D. Imperial) as post disqualified as per issued notices of post disqualification. Further verification with DOLE-CAR on the submitted SLCC of Hexacom Enterprises needs to be conducted.

**WHEREAS**, only **Tionsan Corporation** (Manuel D. Supat, Jr.) and **Ants Technologies** (Abigail D. Imperial) submitted their Motion for Reconsideration (MR) within the three-day reglementary period.

**WHEREAS**, DOLE -CAR submitted certification that Hexacom Enterprises has delivered the items in accordance with the Delivery Schedule and with the Technical Specifications as provided in their bidding documents for the project "Procurement of 1 Lot ICT Resources under the 2023 Computerization Program" and in accordance with the conditions under Contract Number DOLE-CAR 2023 ICTE PB2 the same document as attached by the bidder.

**WHEREAS**, after deliberation review and verification of the grounds relied upon in their MR, the BAC denied the motion for reconsideration filed by TSS Corporation and Ants Technologies for reasons stated in the BAC Resolution No.2024-228 and 2024-227A, respectively.

**NOW THEREFORE**, be it RESOLVED as it is hereby done:

1. To declare the bid of **Hexacom Enterprises** (Malou Y. Yusongco) as the Lowest Calculated and Responsive Bid (LCRB) under project **PROCUREMENT OF INFORMATION TECHNOLOGY (IT) EQUIPMENT FOR BENGUET STATE UNIVERSITY (IB NO. 2024-16.)** (See table below).

Yusongco) at its total bid of **One Million Seven Hundred Sixty Three Thousand Five Hundred Ninety Four Pesos and Eight Centavos Only (Php 1,763,594.08)** vis-à-vis the Approved Budget for the Contract (ABC) of Four Hundred One Thousand Five Hundred Pesos Only (Php 2,372,590.00).
