JONALYN P. LAURIAN, sole proprietor of HEXACOM ENTERPRISES, a business establishment duly registered as a Sole Proprietorship under Philippine Laws having principal addresses at Stall # 1 Adivay Bldg, Bonifacio St., Baguio City, Benguet, CAR, Philippines, 2600. herein referred to as the SUPPLIER;

WHEREAS the BENGUET STATE UNIVERSITY invited Bids for the supply of certain goods and ancillary services, particularly item/lot A-E & G under the project IB 2024-16, as detailed on the table below.

- iv. Supplemental or Bid Bulletins, if any
- Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto;
- v. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration of the sum of One Million Seven Hundred Sixty-Three Thousand Five Hundred Ninety-Four Pesos and Eight Centavos Only (PhP1,763,594.08.00) or such other sums as may be ascertained, JONALYN P. LAURIAN agrees to supply and deliver the goods and services under project Procurement of various Information Technology (IT) Equipment and Supplies for Benguet State University (IB 2024-16), particularly item/lots A-E & G for the said project in accordance with his/her/its Bid.
- The BENGUET STATE UNIVERSITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
