WHEREAS the BENGUET STATE UNIVERSITY invited Bids for the supply of certain goods and ancillary services, particularly Item 3 under the project IB 2024-09B, as detailed on the table below.

WHEREAS after compliance with the procurement law BSU has accepted the Bid by the Supplier for the supply of those goods and services in the sum of Three Hundred Sixty-Two Thousand Six Hundred Ninety-Five Pesos Only (PHP 362,695.00), hereinafter called "the Contract Price" vis-à-vis the ABC of Four Hundred One Thousand Five Hundred Pesos (PHP 401,500.00).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- iv. Supplemental or Bid Bulletins, if any
- Winning bidder's bid, including the Eligibility requirements,
 Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of Three Hundred Sixty Two Thousand Six Hundred Ninety Five Pesos Only (PHP 362,695.00), or such other sums as may be ascertained, MR. MANUEL SUPAT, JR., agrees to supply and deliver the goods under project IB NO. 2024-09B: PROCUREMENT OF INFORMATION TECHNOLOGY (IT) EQUIPMENT FOR BENGUET STATE UNIVERSITY particularly Item 3 in accordance with his/her/its Bid.
- 4. The **BENGUET STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
