- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration of the sum of **Three Hundred Sixty Two Thousand Six Hundred Ninety Five Pesos Only (PHP 362,695.00)**, or such other sums as may be ascertained, **MR. MANUEL SUPAT, JR.**, agrees to supply and deliver the goods under project **IB NO. 2024-09B: PROCUREMENT OF INFORMATION TECHNOLOGY (IT) EQUIPMENT FOR BENGUET STATE UNIVERSITY** particularly **Item 3** in accordance with his/her/its Bid.

4. The **BENGUET STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




