This Contract made and entered into this 14th day of May 2024 by and between:

BENGUET STATE UNIVERSITY, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. FELIPE SALAING COMILA**;

And

GOLD N' GREEN ENTERPRISE a business entity duly organized and existing in accordance with the laws of the Republic of the Philippines, and principal address at Quezon Blvd. Zone III, Bayambang, Pangasinan represented by its owner, **ROD ERIC P. GARAY** herein referred to as the **"SUPPLIER"**.

WITNESSETH

WHEREAS, consonant to the provisions of R.A 9184, the BENGUET STATE UNIVERSITY posted an Invitation to Bid for the project: Procurement of Various Semi-expendable Office Equipment (RFQ 2024-290) in the PhilGEPS, agency website and four (4) conspicuous places continuously starting on April 4, 2024;

WHEREAS, in response to the Invitation, CA Bliss Enterprise and Gold N Green Enterprise submitted their bids on the scheduled submission at 2:00 PM of April 11, 2024;


WHEREAS, during the opening of quotation, the eligibility requirements submitted by the bidders, CA Bliss Enterprise and Gold N Green Enterprise were declared as eligible and, thus subject of post qualification;

WHEREAS, upon careful examination, validation and verification of the legal, technical and financial requirements submitted and stated in its bidding documents, the bid of the herein **SUPPLIER** was found to be compliant and responsive to the requirements of the project. Hence, on April 25, 2024 under BAC Resolution Number 2024-317A, the Bids and Award Committee declared Gold N Green Enterprise was declared as the Single Calculated and Responsive Bid (SCRB) for the following items:






NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or bid bulletin, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;
Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidders agrees that additional documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration of the sum of Five Hundred Forty-four Thousand One Hundred Nineteen and Thirty-three Centavos Only (Php. 544,199.33) or such other sums as may be ascertained, **GOLD N GREEN ENTERPRISE** agrees to particularly for the following lots: Sub-lot I (Whiteboard), Sub-lot II (Paper Shredder and Rotary Cutter), Sub-lot III (Office Chairs), Sub-lot V (centerfold Table, Sub-lot VI (Filing Cabinet) and Sub-lot VII (Sofa Set and Office Table) under the project Procurement of Various Semi-expendable Office Equipment (RFQ 2024-290) in accordance with his/her/its Bid.
4. That the Contract time will be for a period of **Fifteen (15)** calendar days; counted from the supplier's receipt of the Notice to Proceed;
5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
