BENGUET STATE UNIVERSITY (BSU), a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having principal office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. FELIPE SALAING COMILA**;

and

JPM MACROVET SUPPLY a business entity duly organized and existing in accordance with the laws of the Republic of the Philippines, and with principal address at Cauayan City, Isabela, represented by its Proprietor, **ROLANDO M. MUROS** hereinafter referred to as the **"SUPPLIER"**;

W I T N E S S E T H:

WHEREAS, consonant with the provisions of R.A. 9184, the Benguet State University posted an Invitation to Bid (ITB) for the project: **IB. NO. 2024-19: PROCUREMENT OF 2,950 HEADS READY TO LAY PULLETS** in the PhilGEPS, Agency website and four (4) conspicuous places continuously starting April 8, 2024;

WHEREAS, in response to the invitation, **JPM MACROVET SUPPLY** bought and submitted on the scheduled submission at 1:00 PM of April 30, 2024;

WHEREAS, during the opening of bids, the legal, technical and financial requirements submitted by **JPM MACROVET SUPPLY** was determined as the Single Calculated and Responsive Bid (SCRB) thus, subject of post qualification;

WHEREAS, upon careful examination, validation and verification of the legal, technical and financial requirements submitted and statements in its bidding documents, the bid of the herein SUPPLIER was found out to be compliant and responsive to the requirements of the project. Hence, on May 7, 2024 under BAC Resolution Number **2024-382, the Bid and Award Committee (BAC) declared the bid of JPM MACROVET SUPPLY** as the Single Calculated and Responsive Bid (SCRB) for the project: IB. NO. 2024-19: Procurement of 2,950 Heads Ready to Lay Pullets;

WHEREAS, after compliance with the procurement law, BSU has accepted a Bid by the supplier for the supply of those goods and services in the sum of **One Million One Hundred Seventy-Eight Thousand Five Hundred Twenty-Five Pesos Only [Php. 1,178,525.00]**; herein after called the "Contract Price",

WHEREAS, the amount of the contract is One Million One Hundred Seventy-Eight Thousand Five Hundred Twenty-Five Pesos Only (Php. 1,178,525.00);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Condition of Contract referred to.

- a) Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c) Performance Security;
 - d) Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e) Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration of the sum of One Million One Hundred Seventy-Eight Thousand Five Hundred Twenty-Five Pesos Only (Php. 1,178,525.00) or such other sums as may be ascertained, **JPM MACROVET SUPPLY** agrees to particularly supply and delivery of goods under the project: IB No. 2024-19 Supply and Delivery of 2,950 Heads Ready to Lay Pullets with his bid.
4. That the delivery shall be made within September, 2024;
5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the term of the Bidding.


