WITNESSETH

WHEREAS, consonant to the provisions of R.A 9184, the BENGUET STATE UNIVERSITY posted an Invitation to Bid for the project: IB 2024-29 Procurement of Various Reference Books for the College of Medicine in the PhilGEPS, agency website, and four (4) conspicuous places continuously starting on June 10, 2024;

WHEREAS, in response to the Invitation, only C & E Publishing, Inc. bought and submitted their bids on the scheduled submission at 1:30 PM of July 02, 2024;

WHEREAS, during the opening of bids, the legal, technical and financial requirements submitted by the lone bidder C & E Publishing, Inc. was declared as eligible and, thus subject of post qualification;

WHEREAS, upon careful examination, validation and verification of the legal, technical and financial requirements submitted and stated in its bidding documents, the bid of the herein **SUPPLIER** was found to be compliant and responsive to the requirements of the project. Hence, on July 23, 2024 under BAC Resolution Number 2024-740, the Bids and Award Committee declared C & E Publishing, Inc. as the Single Calculated and Responsive Bid (SCRB) for the following item:

WHEREAS, after compliance with the Procurement law, BSU has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Three Hundred Sixty Four Thousand Nine Hundred Sixty Nine Pesos Only (Php. 1,364,969.00)**, hereinafter called the “Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or bid bulletin, if any
 - b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;
3. Bid form, including all documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder’s conforme thereto; and
 - e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The bidder agrees that additional documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
4. In consideration of the sum of **One Million Three Hundred Sixty Four Thousand Nine Hundred Sixty Nine Pesos Only (Php. 1,364,969.00)** or such other sums as may be ascertained, **C & E PUBLISHING, INC.** agrees to the **Supply and Delivery of Various Reference Books for the College of Medicine** in accordance with his/her/its Bid.
5. That the Contract time will be for a period of **Thirty (30)** calendar days; counted from the supplier’s receipt of the Notice to Proceed;
6. The **Benguet State University** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
