PROJECT NUMBER: IB 2024-31
PROJECT TITLE: **PROCUREMENT OF VARIOUS LABORATORY EQUIPMENT FOR THE COLLEGE OF MEDICINE**

This Supplemental/bid bulletin is being issued to advise prospective bidders and to amend certain items in the Bidding Documents in response to the clarifications from prospective bidders during the Pre-Bid Conference held on June 20, 2024. The Bidding Documents and all papers previously issued in relation to the aforesaid project are hereby amended as follows:

- A. Section III. Bid Data Sheet, Section 5.3.b: Completed within five (5) years prior to the submission of bids;
- B. Project Requirements:
 - B.1. Delivery Period – from 15 Calendar days to **30 Calendar days**
 - B.2. Updates on the Specifications of the items:
 - Item 1: Analytical Balance:
Pan size: **at least Ø90**
Main body dimension: at least 345mm(L)x 215mm(W)x 345mm(H) or manufacturer's specifications
AVR: with **compatible AVR** (computed as: *wattage of the equipment X 3*)
 - Item 2: Fumehood
 1. Dimension: at least 47.44 inches x 33.46 inches x 92.52 inches (W x D x H), or manufacturer's specifications
 2. At least 12.7mm **epoxy** worktop with edges
 3. **LCD/LED control panel**: light switch, fan control, alarm system for airflow
 - Item 3: Colony Counter
 1. Dimensions: at least 360 x 300 x 180 (mm), or manufacturer's specifications
 2. Magnification: **3-10 times**
 - Item 4: Hot Plate
 1. Protection Class: IP2X or **IP 21**
 - Item 7: Portable electronic Balance
 1. Dimension: over all at least 210mm (L) x 192mm (W) x 54mm (H), or manufacturer's specifications
 2. Display: LED / LCD
 - Item 8: fully Automatic Autoclave
 1. Type: Vertical
 2. Dimension: at least 24.41 inches (L) x 26.77inches (W) x 40.94 inches (H), or manufacturer's specifications
- C. Financial Proposal
 - Bidding and Awarding is per line items

- D. Checklist of Technical and Financial documents (**additional instructions**)
- I. Envelope A – Technical Component
 2. Statement of the bidder of all its ongoing government and private contracts, including contracts awarded but not yet started
 - a. The bidder must include the names of outstanding contracts with other contracting party, i.e., PE or private company allowed by the rules, contract date, period and amount or value.
 - b. For Goods, kinds of Goods and dates of delivery.
 3. Statement of the Bidder’s SLCC similar to contract to be bid
 - a. Name of the completed contract with contract date, period and amount, which should correspond to the required percentage of the ABC to be bid. The value is adjusted to the current prices using the Philippine Statistics Authority consumer price indices, when necessary
 - b. For Goods, the relevant period or delivery date when the said SLCC was completed; end user’s acceptance or official receipt(s) or sales invoice issued for the contract, if completed;
 - c. Definition or description of the similar project or major categories of work.
 - d. Certificate of Acceptance and/or Official Receipts
 7. Computation of NFCC or committed Line of Credit (CLC) for Goods

****For NFCC*

 - a. ABC to be bid;
 - b. Amount or value of bidder’s current assets based on Audited Financial Statements (AFS);
 - c. Amount or value of bidder’s current liabilities based on AFS; and
 - d. Amount or value of all outstanding or uncompleted portions of the projects under ongoing contracts, including awarded contracts yet to be started, coinciding with the contract to be bid

**** For CLC*

 - a. ABC to be bid;
 - b. Amount, which should be at least equal to ten percent (10%) of the ABC; and
 - c. Name of issuing foreign Universal or Commercial Bank, as confirmed or authenticated by a local Universal or Commercial Bank
 - II. Envelope B- Financial Component
 1. Financial Bid form
 - a. Bid prices in figures and in words; and
 - b. The Bid price shall include the cost of all taxes, such as, but not limited to, value added tax, income tax, local taxes, and other fiscal levies and duties which shall be itemized in the bid form and reflected in the price schedule or detailed estimates.
 2. Price Schedule – please use the form included in Section 9- Bidding Forms

This Supplemental Bid Bulletin No. 2024-10 shall form an integral part of the Bidding Documents. Any provision in the Bidding Documents and other documents inconsistent herewith is hereby amended, modified and superseded accordingly. Other provisions shall remain in full force and effect.
