TERMS AND CONDITIONS:

- a) Bidders shall provide correct and accurate information required in the Price Quotation Form:
- b) Price Quotation must be valid for a period of thirty (30) calendar days from the date of submission;
- c) Award of contract shall be made to the quotation which complies with the technical specification/ requirement and other terms and conditions stated in the price quotation form:
- d) Quotations exceeding the Approved Budget for the Contract shall be rejected;
- e) Single delivery, to be delivered first week of February 2026;

Liquidated damages equivalent to one tenth of one percent (1/10 of 1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. BSU shall rescind the contract once the cumulative amount of the contract exceeded ten percent (10%) of the total contract price, without prejudice to other courses of action and remedies open to it.
