This Contract made and entered into this 4th day of December 2025 by and between:

BENGUET STATE UNIVERSITY, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. KENNETH ALIP LARUAN**;

-and-

DIEGO P. DUMAPIS proprietor of **ZION D&J AGRI-POULTRY SUPPLY**, with business address at Puguís, La Trinidad, Benguet herein referred to as the **“SUPPLIER”**.

WITNESSETH

WHEREAS, consonant to the provisions of R.A. 9184, the **BENGUET STATE UNIVERSITY** posted an Invitation to Bid for the project: Procurement of 2,950 Heads Ready to Lay Pullets (RFQ No. 2025-1648) in the PhilGEPS, agency website and four (4) conspicuous places continuously starting on November 7, 2025;

WHEREAS, in response to the invitation, one (1) bidder, **DIEGO P. DUMAPIS (ZION D&J AGRI-POULTRY SUPPLY)** submitted its quotation on or before the scheduled submission at 8:30 am on November 14, 2025;

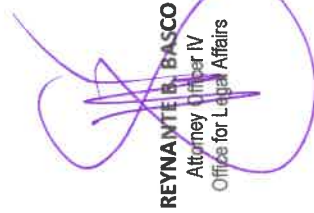
WHEREAS, after checking of the eligibility requirements and financial proposal submitted by the bidder using the “pass/fail” criteria, the bid of **ZION D&J AGRI-POULTRY SUPPLY** was declared the single calculated quotation having submitted all the required documents, subject for post-qualification;

WHEREAS, after careful examination and verification, the bid of the herein **SUPPLIER** was found to have passed all the requirements and conditions specified in the invitation to bid for the project. Under **BAC Resolution Number 2025-1431**, the bid was declared as the Single Calculated and Responsive Bid (SCRB) with a recommendation for award of the project to herein **SUPPLIER**;

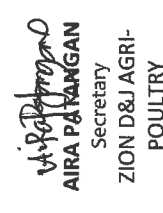

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- a. Invitation to Submit Quotation;
 - i. Valid PhilGeps Registration - Platinum Membership (all pages) in accordance with Section 8.5.2 of the IRR;
 - ii. Notarized Omnibus Sworn Statement;
 - iii. Computation of Net Financial Contracting Capacity (NFCC); or Committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation;
 - iv. Quotations
 - v. Detailed Descriptions of the items;
 - vi. Other supporting documents (e.g. accreditations, exclusive distributorship and others)
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted; Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- c. Performance Security;
- d. Notice of Award of Contract; and the Bidder's conforme thereto; and
- e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The bidder agrees that additional documents or information that are subsequently prescribed and/or required for submission by the GPBB after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the sum of **One Million Two Hundred Fifteen Thousand Four Hundred Pesos Only (Php. 1,215,400.00)**, or such other sums as may be ascertained, **ZION D&J AGRI-POULTRY SUPPLY (DIEGO P. DUMAPIS)** agrees to supply and delivery under the project RFQ No. 2025-1648 Procurement of 2950Heads Ready to Lay Pullets in accordance with his/her/its Bid.

4. That the delivery period will be on the Last week of December 2025; counted from the supplier's receipt of the Notice to Proceed;

5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

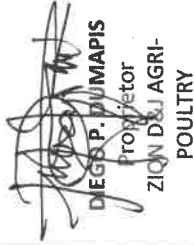

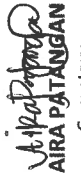

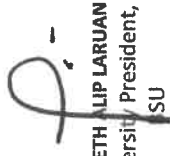
