This Contract made and entered into this 17th day of December 2025 by and between:

BENGUET STATE UNIVERSITY, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. KENNETH ALIP LARUAN**;

-and-

TOYOTA BAGUIO CITY a business entity duly organized and existing in accordance with the laws of the Republic of the Philippines, with business address at Purok 6, Bokawkan Road, P. Burgos, Baguio City represented by its Authorized Representative, **CZARRICH BRIANSLY S. TIONG** herein referred to as the **"SUPPLIER"**.

WITNESSETH

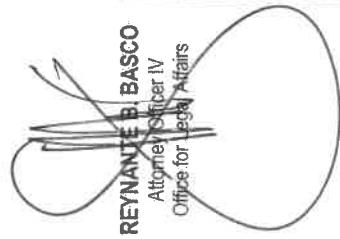
WHEREAS, consonant to the provisions of R.A 9184, the **BENGUET STATE UNIVERSITY** posted an Invitation to Bid for the project: **IB No. 2025-31 Supply and Delivery of 1 Unit Passenger Van for the College of Nursing** in the PhilGEPS, agency website and four (4) conspicuous places, continuously, starting on November 21, 2025;

WHEREAS, in response to the Invitation, one (1) supplier, **Toyota Baguio City**, submitted its bid at 8:27 a.m. of December 15, 2025;

WHEREAS, after checking of the eligibility requirements and financial proposal submitted by the bidder using the "pass/fail" criteria, the bid of **TOYOTA BAGUIO CITY** was declared as the Single Calculated Bid (SCB) and subject for post-qualification;

WHEREAS, after careful examination and verification, the bid of the herein **SUPPLIER** was found to have passed all the requirements and conditions specified in the invitation to bid for the project. Under **BAC Resolution Number 2025-1562**, the bid was declared as the Single Calculated and Responsive Bid (SCRB) with a recommendation for award of the project to herein **SUPPLIER**;

WHEREAS, the **BENGUET STATE UNIVERSITY** accepted the Bid by the Supplier for the Supply and Delivery of 1 Unit Passenger Van for the College of Nursing in the sum of Two Million Three Hundred Thirty-Six Thousand Nine Hundred Sixty and 95/100 Pesos Only (PhP2,336,960.95) hereinafter called the "Contract Price" vis-à-vis the approved Budget for the Contract for the project of Two Million Three

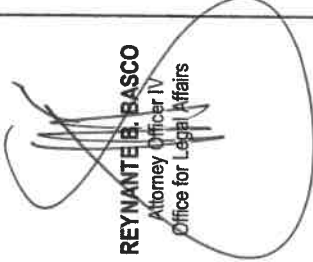

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental bid bulletin, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted; Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The bidder agrees that additional documents or information that are subsequently prescribed and/or required for submission by the GPBB after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the sum of **Two Million Three Hundred Thirty-Six Thousand Nine Hundred Sixty and 95/100 Pesos Only (PhP2,336,960.95)** or such other sums as may be ascertained, **TOYOTA BAGUIO CITY** agrees to supply and deliver the 1-unit passenger van for the College of Nursing in accordance with his/her/its Bid.
4. That the delivery period will be **Forty-five (45)** calendar days; counted from the supplier's receipt of the Notice to Proceed;
5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
