In consideration of the Contract Price of **Two Million Four Hundred Twenty-Five Thousand Four Hundred Eighty-Seven Pesos Only (PhP 2,425,487.00)** or such other sums as may be determined in accordance with the terms of the Contract, the Supplier/Contractor/Consultant agrees to deliver and perform the items and related services for the **SUPPLY AND DELIVERY OF VARIOUS CONSTRUCTION, PLUMBING AND ELECTRICAL SUPPLIES AND MATERIALS FOR BAPTC (IB NO. 2026-09A).**" **(SUB LOTS 1-3)** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

4. The **BENGUET STATE UNIVERSITY** agrees to pay the above-mentioned sum to the Supplier/Contractor/Consultant in accordance with the schedule and manner provided in the Bidding Documents and its annexes.

Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).
