This Contract made and entered into this 4th day of August 2026 by and between:

BENGUET STATE UNIVERSITY, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. KENNETH ALIP LARUAN**;

-and-

PREMIE D. SALAZAR, Project Manager of **MHARDEE'S ENTERPRISE** a business entity duly organized and existing in accordance with the laws of the Republic of the Philippines, with business address at Mayanganay Sta. Maria, Ilocos Sur herein referred to as the **"SUPPLIER"**.

WITNESSETH

WHEREAS, consonant to the provisions of R.A 12009, the **BENGUET STATE UNIVERSITY** posted an Invitation to Bid for the project: Supply and Delivery of Various Construction Supplies for the Repair of Various Buildings (IB No. 2026-15A) in the PhilGEPS, agency website and four (4) conspicuous places continuously starting on July 6, 2026;

WHEREAS, in response to the Invitation, only **MHARDEE'S ENTERPRISE**, bought and submitted its bids on the scheduled submission at 8:30 AM of July 14, 2026;

WHEREAS, after checking of the eligibility requirements (Envelope A) submitted, **MHARDEE'S ENTERPRISE** were declared eligible for having passed the "pass/fail" criteria, hence, the financial proposal were opened and was declared compliant; Thus, declaring the lone bidder was rated "Passed";

WHEREAS, the BAC proceeded with the bid evaluation, as a result, the bid document submitted was complete and compliant to the requirement of the project. The committee declared **MHARDEE'S ENTERPRISE** as eligible and the Single Calculated Bid (SCB) and subjected for post qualification;

WHEREAS, after careful examination and verification, the bid of the herein **SUPPLIER** was found to have passed all the requirements and conditions specified in the invitation to bid for the project. Under **BAC Resolution Number 2026-865**, the bid was declared as the Single Calculated and Responsive Bid (SCRB) with a recommendation for award of the project to herein **SUPPLIER**;

WHEREAS, the **BENGUET STATE UNIVERSITY** has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **One Million Nine Hundred Fifty-three Thousand Five Hundred Sixty Pesos Only (Php. 1,953,560.00)**; for the **project**, hereinafter called the “Contract Price” vis-à-vis the approved Budget for the Contract of One Million Nine Hundred Ninety-three Thousand Five Hundred Eighty-five Pesos Only (Php. 1,993,585.00);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 12009 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or bid bulletin, if any

- b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted; Bid form, including all documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- c. Performance Security;

- d. Notice of Award of Contract; and the Bidder’s *conforme* thereto; and

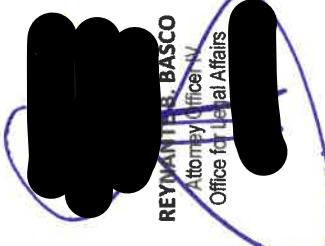
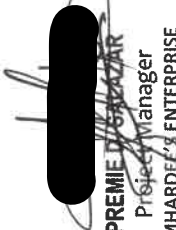
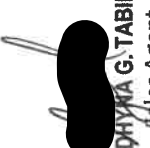
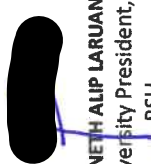
- e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The bidder agrees that additional documents or information that are subsequently prescribed and/or required for submission by the GPBB after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the sum of **One Million Nine Hundred Fifty-three Thousand Five Hundred Sixty Pesos Only (Php. 1,953,560.00)**; for the project, or such other sums as may be ascertained, **MHARDEE’S ENTERPRISE (PREMIE D. SALAZAR)** agrees to supply and delivery under the project IB No. 2026-15A Supply and Delivery of Various Construction Supplies for the Repair of Various Buildings in accordance with his/her/its Bid.

4. That the delivery period will be **Thirty (30)** calendar days; counted from the supplier’s receipt of the Notice to Proceed;

5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

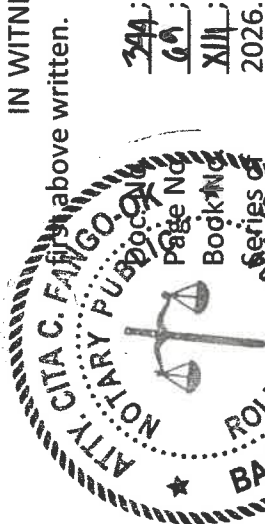
