TheMostDistinguished Teacher Awardee may be endorsed as the University's representative for Search of Outstanding Teacher by external award giving bodies.

#### **Selection Procedure**

1. The Department Chair shall nominate at most three qualified faculty members in the department to the College Evaluation Committee, in accordance with the selection instrument.

## BSU employees receive rice incentive

Based on a resolution adopted by the BSU Non-Teaching Association (BSUNTA) on March 27, 2012, University employees are now receiving an incentive in the form of rice.

"Whereas, the Association recognizes the continuing escalating economic crises being experienced not only by BSU employees but by the Filipino people in general.

"Whereas, in response thereto, the University has been customarily giving rice to its constituents during the previous years. This is according to an equity-based sharing from the net income of the University's Income Generating Projects (IGPs), particularly under Revolving Fund 161 and Revolving Fund 163 (RF 161 & RF 163)," the resolution stated.

Permanent, contractual, and job order employees of the University are the grantees of this annual incentive. //

- 2. The College Evaluation Committee shall evaluate the credentials of the faculty nominees endorsed by the Departments. They shall also rate the department nominees in classroom or micro-teaching demonstration
- 3. The College Evaluation Committee shall then recommend to the University Selection Committee those with scores of at least 85.
- 4. The University Evaluation Committee shall determine the top five nominees and

- recommends the same to the PRAISE Committee for final review and confirmation.
- 5. The Praise Committee shall declare the Most Distinguished Awardee and the Outstanding Teacher.
- 6. The decision of the Praise Committee shall be final.

## Qualifications and Disqualifications:

The following faculty members may be nominated for the award:

- 1. Full time permanent faculty member who has served the University continuously for at least five (5) years before the search.
- 2. Should have at least 18 units of actual teaching load per semester for the last two (2) semesters preceding the semester of the search.
- 3. Should have at least a master's degree.
- 4. Should have a score of at least 85 points using the selection instrument.

5. Should have a rating of Outstanding in the Classroom/Micro-Teaching Demonstration.

The following faculty members are disqualified from being nominated:

- 1. Those who are holding administrative positions at the time of the search;
- 2. Members of the Search Committee;
- 3. Previous University Most Distinguished/Outstanding Teacher awardees;
- 4. Those with pending criminal or administrative cases.

#### **Required Documents**

- 1. PES evaluation for the last two (2) semesters preceding the date of award certified by the Human Resource Management Office.
- 2. Photocopy/copy/e-copy of instructional materials developed duly approved/accepted by concerned Dean. For instructional materials with copyright or its equivalent (for web-based publications), certification from the Department Chairman of it being used by faculty member in his/her classes will take the place of the Dean's/Director's approval.
- 3. Photocopies of certificates of participation in seminars/ conferences/trainings attended, certified by Dean/Director concerned.
- 4. Certificates of academic distinction (if any).
- 5. Certificates of membership in professional organizations.
- 6. Certified photocopy of Abstract of completed researches by the Director of Research or Vice President of Research and Extension.
- 7. Certified photocopy, photograph, certifications for creative and literary works and innovations, by the Dean/Director concerned.
- 8. Evidence of conduct/participation in extension activities or community service.
- 9. Certificates of appreciation as speaker, lecturer, or resource
- 10. Certificates of membership in civic/religious organizations.

#### Selection Criteria

- -Teaching competencies 75%
- -Research and/or Creative Outputs within the last 10 semesters including summer terms - 10%
